- C. <u>Budget Update</u> & <u>Legislative Update</u> The Senate version of the Budget Bill (HB 64) was released Tuesday, June 9, 2015. According to cursory review, it appears that the Board's request for the automatic suspension and the request for increase in appropriation to implement a regularly scheduled compliance inspection are in the Senate version. The Board will have to wait for the final version of the bill to know what is eventually enacted.
