- **September 2009 Minutes Approved:**

Dr. Small moved to accept the September board meeting minutes with one minor edit. Dr. Mach seconded the motion. The motion passed by the following roll call vote: Dr. Mach-aye, Mr. Smith-aye, Dr. Small-aye, Dr. Gitz-aye, Dr. Hearst-aye, Ms. Jessen-aye.

- **President's Report:**

A. AAVSB Conference - Dr. Redman updated the Board on issues presented at the AAVSB conference such as an update on internet pharmacies, utilizing RACE for all CE approvals, and the availability of an online recordkeeping CE that can be used in disciplinary cases.

- **Secretary's Report:**

There was no report from the Secretary.

- **Executive Director Report:**

- A. Directives – Ms. Stir provided the Board with the progress of the September Board meeting directives.
- B. Fiscal – Ms. Stir provided Q1 FY10 fiscal documents for revenue, expenses, and the OAKS Budget Overview with balances. \$190.00 was transferred to the Veterinary Student Loan Repayment program for Q1 FY10 from veterinary renewals.

Ms. Stir informed the Board that the Auditor of State informed the Boards and Commissions that due to decisions made in HB 1, the Auditor is required to conduct annual audits of the Board and will now bill the agency directly for the costs. Previously, there was a fund set up for the costs of the audits. The audit is an unanticipated expense with the anticipated cost per hour being \$60-70 with a minimum of 40 hours.

- C. AAVSB Veterinary Regulation News– Ms. Stir asked the Board to review The Legal Corner article on Page 2 and 3 of the newsletter regarding definitions of “Specialist” and “veterinarian”. The Board determined that Ohio’s definition of “specialist” met the legal issues raised in the article. However, Ohio’s law does not define “veterinarian”. Dr. Mach reviewed the Veterinary Medical Practice Act and identified areas of the law that passes the legal concerns raised in the article. Dr. Mach asked, with Board consensus, that the information be placed on the Board’s web site in the licensure section so veterinarians know the definition of specialists versus veterinary practice.

- **Discussion with Director Winsley of the Ohio Board of Pharmacy**

Dr. Redman asked for the Board’s indulgence to go out of order of the Agenda in order to accommodate Director Winsley’s time. Dr. Redman also acknowledged the presence of Jack Advent, Executive Director for the Ohio Veterinary Medical Association.

The issue as originally presented to Director Winsley was who can handle the drugs in the veterinary office? Additionally, can a receptionist hand a prescription to a client that the veterinarian has filled previously, but is out to lunch when the client arrives?

Mr. Winsley pointed out that his answer applies to controlled substances and dangerous drugs (prescription drugs). It does not apply to over-the-counter medications.

After reviewing pertinent sections of the law, the basic answer is:

- The Veterinarian can assign someone (not necessarily an RVT) to pull out the drug, count it and label it. However, the veterinarian must lay hands on the finished product for verification purposes. There must be a mechanism in place to show that the veterinarian “approved” the finished product.
- Section 4729.29 ORC permits the veterinarian to “personally furnish” a prescription. Therefore, the veterinarian **MUST** be on the premises when the prescription is given to a client.

In response to a question, Director Winsley stated that a veterinarian is only authorized to personally furnish to their own patients—not another veterinarian’s patients, which is why veterinarians cannot borrow medications from each other.

For further clarification, the question was asked could the receptionist get in the controlled substance cabinet and count out the controlled substance. Director Winsley stated that there must be a method in place to detect and deter diversion. The Board does not specify what that method

should be or that it is written, just that it is in place and everyone knows what it is. A few examples of “deter and detect” are locks on the drug cabinet, door alarms, fingerprint access, etc.

The veterinarian could assign specific individuals access to the drugs; however, it is recommended that unlicensed individuals should not have access if the veterinarian is not there on the premises. The system should be set up in a way that the veterinarian is in charge of the pharmaceuticals and that **all** prescription drugs are accounted for, not just controlled substances. Mr. Winsley stated that typically the veterinarian will not know that there is an issue with their “detect and deter” system until a problem arises (i.e. drugs come up missing).

There was some discussion of internet pharmacies and the Board was warned to watch for pharmacies stationed in Florida or internationally.

Dr. Mach read an article, *Diversity Matters*, that she prepared regarding diversity in veterinary practice to be placed on the web site or included in the board newsletter (See Addendum A). After much discussion, Dr. Mach moved to put the letter on the OVMLB web site. The motion died for lack of a second. It was recommended to place language that reflects that “discipline cases are redacted prior to Board deliberation” on the web site under complaint information.
