8. Ohio Board of Pharmacy - Director, Steven Schierholt, Esq., Cameron McNamee, Director of Policy and Communications, and Sherri Zapodka, Compliance Specialist were present to discuss issues related to the pharmacy law and rules.

**9. Executive Director Report:**

A. Directives – The July 2015 Board meeting Directives have been completed.

B. RVT Presentation – The Ohio Association of Veterinary Technicians has requested a board member to present at their Discovery 2015 conference on October 11, 2015. Board members will check their schedules for availability.

C. Rule Update – The Lt. Governor’s office did not have any comment on the Business Impact Analysis filed with them for proposed amendments to Rule 4741-1-04 OAC. Therefore, it is okay to file the rule with the Joint Commission on Agency Rule and Review. Due to the timing, the rule will be filed September 8, 2015 so that there will be a public rules hearing at the October board meeting.

D. Policy Review – The next policy to be reviewed by the Board members was Policy section 5. The following changes were proposed:

- Currently Policy 5.1 is the Employee Manual. There were some modifications necessary as a result of the recent collective bargaining agreement. Examples include: personal time can only be taken in two (2) hour increments; an initial probationary period will now be 365 days from the effective date of hire; verbal and written reprimands are consolidated into one category. Additional changes included sections of Department of Administrative Service (DAS) state policies.
- Policy 5-B is to be rescinded and incorporated into the Performance Evaluation Policy in Section 6. Policy 5.2 is the new criminal conviction policy as a result of recent legislation.
- Policy 5-C is being rescinded and included in Policy 5.3. New Policy 5.3 is the discipline grid policy this is inclusive of the new collective bargaining agreement terms.
- Policy 5.4 mirrors DAS’s policy on Drug Free Workplace.
